	<p>a) The risk involved is that there is a possibility that the heirs are not aware of the creation of the wasiat by the testator. Nevertheless, 2 custody cards showing the existence of the wasiat will be provided and it is the obligation of the testator to provide the cards to his/her heirs.</p>

	b) The heirs may also contest the contents of the wasiat and change the apportionment of the estates with approval from all the heirs. This may delay the process if there are any heirs who object the changes.
